## **Action Alert!**

We need your help to keep marijuana (Delta-8 THC) Messes Out of Texas!

The Hemp industry is converting <u>CBD</u> into different variations of <u>THC</u>, the psychoactive chemical that produces the "high" in the marijuana plant. These products are causing harm (see article below), like addiction and psychosis, and are being sold everywhere, including gas stations and convenience stores. The hemp industry is also promoting these THC variations in candies, vapes, and oils that are designed to hook our kids. Delta-8 THC is one of these variations. Texas courts are currently deciding if Delta-8 THC is legal in Texas and we need your help reporting these products to get them off the market and out of the hands of our children.

Please keep reading on how you can help and refer to the letter and article at the bottom of this email for more information.

#### Dear members,

Today, I reached out to Ken Paxton's office to try to find out the legal status of Delta-8 THC in the state of Texas. I spoke with Adrian, who is the Constituent Affairs Agent. His statement was that the office is against it, but there are no current press releases from the office clarifying today's legal standing.

Since the official position is against Delta-8 THC, he suggested we all file reports on sales and advertising to help them track and handle Delta-8 THC sales. This can be done one of two ways:

- 1. Call the Office of the Attorney General Main Switchboard at (512) 463-2100 or Constituent Affairs at (800) 252-8011. Ask to speak with Adrian and he will take the information over the phone.
- 2. Visit <a href="https://www.texasattorneygeneral.gov/contact-us">https://www.texasattorneygeneral.gov/contact-us</a>, click on *Consumer Protection*, then *File a Complaint*. We can file official complaints there. Please note that these complaints will be public.

## **Preparing Your Complaint**

Before you file your complaint with us, take a moment to make sure you have all of your important information. Please note: The system cannot save your complaint in progress, so you will need to complete the form in one sitting. The more details you can provide, the more effectively we can review your complaint. Important information includes:

- The name of the business or individual you're filing a complaint against
- The business/individual's full address, including zip code
- A detailed description of your complaint
- Explanation of how you came into contact with the business/individual
- Transaction dates and amounts
- Contract information (when appropriate) with payment details
- How you may have attempted to resolve the dispute, including the names of people you spoke with

**Note:** You can also attach supporting documents when filling out the online complaint form.

We need to keep doing our part to keep the marijuana Delta-8 messes out of Texas.


