1. HB 218 would actually legalize up to 2 ounces (~57 grams or 57,000 mg) of marijuana.

2 ounces of dry marijuana equals about 120 joints

A joint from the 1990s had about 5% THC which equals 50 mg of THC in each joint.

Today's joint is at least 4 times stronger (20% THC), so each joint in today's market has about 200 mg of THC.

120 joints x 200 mg THC = up 24,000 mg of THC!

That's a lot of marijuana! People with this much THC are usually trafficking this drug!
